## Disclaimer and Assumption of Risk

Each person listed on page one of this document has declared they are voluntarily participating in the indicated tour, led by Whitehawk Birding and Conservation Tours S.A. (henceforth known as Whitehawk), and are fully aware of the risks and hazards connected with the tour's activities. Therefore, each person registered for the tour (henceforth known as the Client) understands that this Disclaimer and Assumption of Risk (Disclaimer) covers and applies to all activities as part of the trip named above. All Minor Participants (17 years of age or younger) registered for this tour must be accompanied by at least one parent or legal guardian. The parent or legal guardian, being fully cognizant of the risks of participating in The Tour hereby voluntarily assumes those risks on behalf of Minor Participant.

The Client understands and agrees that neither Whitehawk nor any of its respective employees, officers, agents and assigns (hereinafter referred to as the "Released Parties") may be held liable or responsible in any way for any injury, death, or other damage to his/her person or his/her family, heirs or assigns that may occur as a result of participating in these activities or as a result of the negligence of any party, including Released Parties, whether the negligence is passive or active.

It is recognized that Whitehawk acts as an agent only during the duration of the tour and assumes no responsibility for any damage, injury, loss, accident, theft, delay or irregularity which may be caused by defects in the transport vehicle or any other cause, nor for the action or inaction of any company or person involved in transporting the passenger or in making their travel arrangements.

As a condition of being allowed to participate in a tour, the Client personally assumes all risks associated with any and all tour activities, including any injury or damage to self or property that may occur, including all the associated risks, whether foreseen or unforeseen. These activities may include travel in all types of vehicles, including animal-drawn vehicles, and travel by foot. The Client understands that at times, the tours involve physically-demanding activities that may cause physical strain that is not necessarily experienced in everyday situations, and in case of injury, including injuries resulting from a heart attack, panic, hyperventilation, altitude sickness or other injuries caused by physical exertion, the Client will assume the risk of such injuries and hold harmless the Released Parties. Also, the Client understands that wildlife watching trips naturally involve certain risks, including contact with potentially dangerous wildlife, possible infection from tropical diseases, or travel over uneven, rugged terrain. The Client also understands that these tours can involve visits to locations that are remote, either in travel time or in distance, and that this entails some inherent difficulties and risks, including longer travel time to a hospital in an emergency.

Whitehawk reserves the right to substitute hotels for others of similar quality as those indicated in the trip itinerary and to make changes to the itinerary if deemed necessary or caused by changes in flights. Whitehawk also reserves the right to cancel any trip prior to departure in which case it will return the full amount of the deposit to the Client. Whitehawk reserves the right to assign different tour leaders for any tour than those mentioned on the website or in the itinerary. If this is necessary, Clients will be notified prior to departure. Tour prices are based on tariffs and exchange rates in effect on January 2, 2016 and are subject to change.

Whitehawk and its agents cannot accept responsibility for losses or additional expenses due to illness, bad weather, strikes, war, quarantine or other causes, nor for delay or changes in flights or other services. Such losses or expenses will be borne by the Client, as the cost of the tour only covers travel arrangements during the set time. The Client acknowledges that he or she has obtained or will obtain travel insurance valid for the duration of the tour and that personal luggage is his/her responsibility alone.

The Client acknowledges and agrees that this Release shall be effective and valid for all activities with Whitehawk from the initial implementation date of this Release. The client intends that this Waiver and Hold Harmless Agreement shall bind the members of his/her family and spouse, if alive, and his/her heirs, assigns and personal representative, if deceased, and shall be deemed as a Release, Waiver, Discharge, and Covenant not to sue the above-named Released Parties. The client hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the Republic of Panama and that any mediation, suit, or other proceeding must be filed or entered into only in the courts of the Republic of Panama. Any portion of this document deemed unlawful or unenforceable is severable and shall be stricken without any effect on the enforceability of the remaining provisions. The Client declares that he is of age and has the legal authority to sign this liability release, or has obtained the written consent of a parent or guardian.

The Client has been fully informed of the contents of this disclaimer and assumption of risk, having read it before signing on his/her behalf and on the behalf of his/her estate and understands the terms herein are contractual and, and signed it willingly (If more than one Client is registered on this form, all adult participants' signatures are required).
